ASTHMA ACTION PLANS: Getting them from point A to point B

It's about that time again; the kids are back in school after a summer full of fun. It's also time for Back-To-School an updated Asthma Action Plan (AAP) and medicine list to be sent to their school. If your patient Asthma + Allergy received an AAP for camp during the months of June, July and/or August, that same Asthma Action Plan can be used for the 2016-2017 school year.

Checklist

You've completed the AAP, saved a copy in the EMR, provided one to the patient's guardian and now need to get one to the child's school. Having trouble ensuring that the AAP actually gets there?

Here are a few tips:

- ⇒ Ask the guardian to place the form in their child's book bag as soon as they get home from the doctor's visit
- ⇒ Follow-up with the family to ensure their child has provided it to the school
- ⇒ Inquire about which school their child attends (or ask the child directly). Obtain permission to send the signed AAP to the school via fax once the appointment has concluded

Need a little more help with ensuring all the boxes are checked before sending them off? Here's a Pediatric Asthma Intervention Checklist that BPHC developed which can be used for all asthmatic patients, no matter the time of year.

GREEN CLEANING IN THE SCHOOL

Worried about your patient's asthma while they're in school? Here are actions currently being taken in Boston Public Schools and Early Education Centers:

- * All schools are cleaned with green certified cleaners. BPS is switching to a "safer sanitizer" that is hydrogen peroxide based in place of bleach. While sanitizers are not necessarily green, they are safer for asthmatics. Here's more information on BPS's Healthy School Policies.
- * There are new guidelines for EEC's to begin using wipe-able mats instead of rugs to support integrated pest management.
- * MassCOSH (MASS Coalition for Occupational Safety & Health), in partnership with HRiA (Human Resources in Action) have created a Green Cleaning Flyer based on CDC recommendations that they are distributing to schools.



BREATHE EASY AT HOME (BEAH) REFERRAL TIPS

Making a referral through the BEAH online web portal? Here are a FIVE important tips:

1. Obtain guardian's permission BEFORE making a referral and explain what the BEAH program does

There are multiple flyers in various languages on our website that explain the program. There are also four videos on our Breathe Easy at Home YouTube page, each less than 3 minutes long, explaining the inspection pro-

2. Double check that the patient's address is correct

If we cannot get in touch via a phone call with the patient's guardian, the Inspectional Services Department (ISD) will send a letter with an inspection date to the address provided.

3. Enter the parent/guardian's name if the referral is for someone under the age of 18

"A parent's guard immediately goes up when they receive a call from City of Boston asking to speak to their child"

The ISD Head Clerk will call the number provided and ask for the person who's name was listed in the referral to verify the address provided and to set up an inspection. To help get the conversation started on the right foot enter the name of the adult in the home.

4. Track your referrals*

If you/your health care site makes multiple referrals, the best way to stay on top of them is to track them in an excel sheet or a Google Doc. Include information like the guardian's name, the patient's name, and the date of

5. Don't be afraid to contact the BEAH coordinator!

The program coordinator (Theresa) is more than happy to speak to you and/or your patient's guardian regarding BEAH to better explain the process and answer any questions. I'm also available to your healthcare facility twice a year (once every six months) to train new staff, re-train seasoned staff in the referral process and provide technical assistance with the website. TRACKING YOUR REFERRAL: Boston Medical Center's Method

To increase the care given and utilize the BEAH program to it's full capacity, Annie Laws, Pediatric Program Coordinator at Boston Medical Center (BMC), has developed a standard tracking system for Breathe Easy referrals. You can view her system here: Tracking Breathe Easy at Home Referrals Through REDCap & EPIC.

Once Annie receives a request for a referral she contacts the family and explains the program prior to making the referral, she then makes a note in the patient's chart. Next, she adds the patient to an EPIC list titled "OPEN Home Inspections", making it easy to see the number of referrals open. She also enters this information into RED-Cap. Annie updates the patient's file every time an update is made by the BEAH coordinator, which is received through email. Completed referrals move to the "CLOSED Home Inspection" list which can be referenced later on if necessary. Do you think your health center could benefit from a similar system?
