**Applicant**: Michael Buccini **Proposed work**: Replace existing concrete street light with metal street light and small cell wireless infrastructure including radio cabinet and antenna.

20.1083.223 Christian Science Church Complex – 210 Massachusetts Avenue Applicant: Daniel Murray Proposed work: At fountain remove and replace bricks in-kind to accommodate replacement of trough grates, and waterproof trough.

**Proposed work**: At Pearl Street elevation install four new handrails at existing entry steps, and at the Oliver Street elevation create an opening in the masonry wall and install a louver.

**II. (To avoid potential confusion, the text of your building-permit application should be consistent with the project description given below.) Commission staff will accordingly authorize the execution of the work, attaching any applicable provisos, reflecting the relevant guidelines and precedents.

**PLEASE NOTE THAT FOLLOWING ISSUANCE OF THE DETERMINATION SHEET NO FURTHER CORRESPONDENCE WILL BE ISSUED** for the applications listed below. The electronic buildingpermit application as annotated by commission staff will constitute your Certificate of Appropriateness; this will be valid for two years from the date of the hearing. The applicant is required to notify the commission of any project changes; failure to do so may affect the status of the approval.
