COMMITTEE HEARING NOTICE

January 19, 2021

The Boston City Council's Committee on Ways & Means will hold a public hearing on Friday, January 22, 2021 at 10:00 AM. This hearing will be held virtually.

The subjects of the hearing are:

Docket #0114, message and order approving a supplemental appropriation of One Million Eight Hundred Fifty Seven Thousand Two Hundred and Twenty Dollars (\$1,857,220.00) for the Boston Public Schools for FY21 to cover the cost items contained within the collective bargaining agreements between the Boston School Committee and the Boston Association of School Administrators and Supervisors (BASAS); and

Docket #0115, message and order to reduce the appropriation for the Reserve for Collective Bargaining by One Million Eight Hundred Fifty Seven Thousand Two Hundred and Twenty Dollars (\$1,857,220.00) to provide funding for the FY21 cost items contained within the collective bargaining agreements between the Boston School Committee and the Boston Association of School Administrators and Supervisors (BASAS).

These matters were sponsored by Mayor Martin J. Walsh and were referred to the Committee on January 13, 2021.

NOTICE: The Boston City Council may have a quorum in attendance due to standing committees of the City Council consisting of both voting and non-voting members. However, members attending this duly posted meeting are participating and deliberating only in conjunction with the business of the standing committee.

Attendance In accordance with Governor Baker's March 12, 2020 Executive Order modifying certain requirements of the Open Meeting Law and relieving public bodies of certain requirements, including the requirement that public bodies conduct its meetings in a public place that is open and physically accessible to the public, the City Council will be conducting this hearing virtually. This enables the City Council to carry out its responsibilities while adhering to public health recommendations and ensuring public access to its deliberations through adequate, alternative means.
