PHC 1. On a petition by Madison Park Development Corp. (d/b/a 75 Dudley LLC) for the acceptance of a **Pedestrian Easement** adjacent to the following public ways in Roxbury:

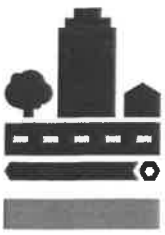
- **Dudley Street** – on its southerly side at address nos. 75-81, between Guild Row and Kenilworth Street;
- **Guild Row** – on its westerly side south of Dudley Street.

PHC 2. On a petition by Madison Park Development Corp. (d/b/a 75 Dudley LLC) for the making of **Specific Repairs** within the following public ways in Roxbury, consisting of curb realignment as well as sidewalk and pedestrian ramp reconstruction:

- **Dudley Street** – on its southerly side at address nos. 75-81, between Guild Row and Kenilworth Street;
- **Guild Row** – on its westerly side south of Dudley Street.

PH 1. On a petition by the City of Boston Public Works Department for the making of **Specific Repairs** within the following public ways in Dorchester, consisting of curb realignment, sidewalk and roadway reconstruction, as well as new and relocated pedestrian ramps, specialty pavement, street lights, stormwater drainage infrastructure, driveway curb cuts, flexposts, and a center median island:

- **River Street** – at its intersection with Edgewater Drive;
- **Edgewater Drive** – south of River Street.

PH 2. On a joint petition by Massachusetts Bay Transportation Authority and City of Boston Public Works Department for the making of **Specific Repairs** within the following public ways in Brighton, consisting of curb realignment, sidewalk reconstruction, as well as new and relocated pedestrian ramps:

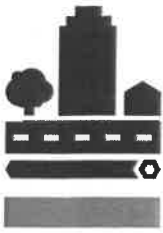
- **Washington Street** – on both sides generally between Montfern Avenue and Fairbanks Street;
- **Oak Square Avenue** – north of Washington Street;
- **Fairbanks Street** – north of Washington Street.

- **Seaport Boulevard** – on its southwesterly side southeast of Pier 4 Boulevard; on its northeasterly side northwest of Fan Pier Boulevard/Thompson Place; on its northeasterly side generally between Sleeper Street and Fan Pier Boulevard; within its center median southeast of Sleeper Street;
- **Pier 4 Boulevard** – on its southeasterly side generally across from Autumn Lane.
