Proposed Work: At all facades, replace all wood windows with correct(existing) window pane configuration; aluminum clad, double hung, true divided light windows. Garage will have windows replaced; windows will be 6 over 6, aluminum clad true divided light. Basement windows will be three vertical lights, replace, and non-original egress stairway in back of the building. Enlarge (2) south facing basement window for egress. Install four flat install skylights at rear.

Proposed Work: Build new deck

II. (To avoid potential confusion, the text of your building-permit application should be consistent with the project description given below.) Commission staff will accordingly authorize the execution of the work, attaching any applicable provisos, reflecting the relevant guidelines and precedents.
- ▶ PLEASE NOTE THAT FOLLOWING ISSUANCE OF THE DETERMINATION SHEET NO FURTHER CORRESPONDENCE WILL BE ISSUED FOR THE APPLICATIONS LISTED BELOW. The electronic building-permit application as annotated by commission staff will constitute your Certificate of Appropriateness; this will be valid for one year from the date of the hearing. The applicant is required to notify the commission of any project changes; failure to do so may affect the status of the approval.
