Hearing Minutes

HM 1. At the request of the Public Improvement Commission staff, the **Acceptance of the Minutes** of the PIC hearing held on **June 30, 2022**.

Utility Pole Hearing

UP 1. On a joint petition by Eversource Energy and Verizon New England Inc. for a **Utility Pole Installation** within **Harvester Street** (public way), Brighton, to relocate one private utility pole to be located on its northerly side generally at its intersection with Sinclair Road.

UP 2. On a joint petition by Eversource Energy and Verizon New England Inc. for a **Utility Pole Installation** within **Fairmount Avenue** (public way), Hyde Park, to relocate one private utility pole to be located on its southwesterly side at address nos. 243-247, northwest of Summit Street.

Public Hearing

PH 1. On a petition by 1135 Harrison Ave LLC for the acceptance of a **Pedestrian Easement** adjacent to the following public ways in Roxbury:

- **Taber Street** – on its northerly side at address no. 16, west of Harrison Avenue;
- **Harrison Avenue** – on its westerly side at address no. 1135, between Taber Street and Palmer Street/Shabazz Way;
- **Palmer Street** – on its southerly side, west of Harrison Avenue.

PH 2. On a petition by 1135 Harrison Ave LLC for the making of **Specific Repairs** within the following public ways in Roxbury, consisting of curb, sidewalk, and pedestrian ramp reconstruction, as well as new and relocated specialty pavement, street trees, street lighting infrastructure, bike racks, and driveway curb cuts:

- **Taber Street** – generally at address no. 16, west of Harrison Avenue;
- **Harrison Avenue** – on its westerly side at address no. 1135, generally between Taber Street and Palmer Street/Shabazz Way;
- **Palmer Street** – west of Harrison Avenue.

(NB 6/30/2022) As shown on a plan entitled “City of Boston Public Works Department, Engineering Division, Specific Repairs, 16 Taber Street, Harrison Avenue, Taber Street, & Palmer Street, Roxbury,” 1 sheet dated July 11, 2022.

PH 3. On a petition by Verizon New England Inc. for a **Grant of Location** with lead company status and no participants to install new telecommunication conduit with City shadow within the following public ways in Roxbury:

- **Burke Street** – from the side of no. 716 Columbus Avenue to Tremont Street;
- **Tremont Street** – northeast of Burke Street.

- **Smith Street** – from address no. 40 to Parker Street;
- **Parker Street** – generally at Smith Street/Gurney Street.
