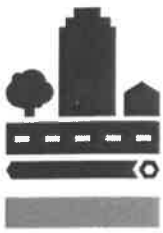
Public Hearing

PH 2. On a petition by Roxbury Preparatory Charter School for the making of **Specific Repairs** within the following public ways in Roxbury, consisting of curb realignment, roadway and sidewalk reconstruction, as well as new and relocated pedestrian ramps, specialty pavement, street lighting infrastructure, stormdrain infrastructure, street trees, landscaping, green stormwater infrastructure, bike racks, driveway curb cuts, and a raised crosswalk:

- **Proctor Street** – at address no. 69, generally northeast of Norfolk Avenue;
- **Magazine Street** – northeast of Kemble Street.

PH 3. On a petition by Extenet Systems Inc. for a **Grant of Location** with lead company status and no participants to install new telecommunication conduit with City shadow within the following public ways in East Boston:

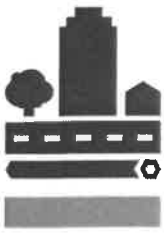
- **Marion Street** – between Trenton Street and White Street;
- **Meridian Street** – between White Street and Condor Street;
- **Trenton Street** – northeast of Marion Street;
- **White Street** – between Marion Street and Meridian Street.

- **Huntington Avenue** – on its northwesterly side between Blagden Street and Dartmouth Street;
- **Blagden Street** – at Huntington Avenue.

PH 5. On a petition by National Grid for a **Grant of Location** to install a gas regulator station and associated infrastructure within the following public ways in Boston Proper:

- **Huntington Avenue** – generally between Blagden Street and Dartmouth Street;
- **Dartmouth Street** – at Huntington Avenue.
