Utility Pole Hearing

- UP 1. On a petition by Eversource Energy for a **Utility Pole Installation** within **Gardner Street**, Brighton, to install one new private guy anchor to be located on its northerly side generally east of Malvern Street.
- UP 2. On a joint petition by Eversource Energy and Verizon New England Inc. for a **Utility Pole Installation** within **Canterbury Street**, West Roxbury, to install four new private utility poles to be located on its northwesterly side generally northeast of Bourne Street.
- UP 3. On a petition by Verizon New England Inc. for a **Utility Pole Installation** within **Millet Street**, Dorchester, to install one new private utility pole to be located on its westerly side at address no. 75, generally south of Park Street.
