Equitable Emissions Investment Fund



From <u>BERDO Ordinance</u>

Purpose

"Money in the Fund shall be expended for the support, implementation, and administration of local building carbon abatement projects that benefit the City of Boston's emissions reduction goals. Fund expenditures shall prioritize projects that benefit Environmental Justice Populations and populations disproportionately affected by air pollution, including by improving or promoting:

- Low-income affordable housing and housing where tenants are at risk of displacement and in need of rent stabilization
- Local air quality improvement;
- Indoor environmental quality and health for building tenants
- Economic inclusion, training, and technical assistance for Minority, Women, and Disadvantaged Business Enterprises (MWDBE) and cooperative contractors
- Equitable workforce development training programs for residents who have been disproportionately impacted by the effects of climate change
- Projects with community ownership of housing and renewable energy infrastructure
- Reduced energy burdens
- Any further environmental initiatives."

Equitable Emissions Investment Fund



- Seeded with \$3.5 million by the Mayor
 - \$175,000 expended to date on Community Advisory Group facilitation and stipends, and Review Board stipends
- Alternative Compliance Payments (ACPs) will go directly into the Fund
- The BERDO Review Board will review project proposals, make recommendations for expenditures, and set conditions for expenditures.

Public feedback opportunity opened on March 15, 2024 and closed on April 30, 2024.



Who submitted feedback

- 3 organizations submitted letters
 - A Better City
 - Boston Climate Action Network
 - Sierra Club Massachusetts
- 50 ACE members sent emails
- 10 individuals responded to the survey

Core themes identified from submitted letters and emails

Draft Application Outline

- Suggestions to request more information from applicants
 - An applicant's funding accomplishments
 - An applicant's financial size and stability (990 form)
 - References for project team members
 - For contractors, request a list of relevant projects and references
- Suggestion to cut the question asking for resumes
- Suggestions to add tenant-specific questions
 - Whether any tenants will be displaced and plans for relocation assistance
 - Ask if building owners are willing to sign a rent stabilization agreement
- Add a question explicitly asking plans to use labor from local, co-op, MBWE, disadvantaged business enterprises, and/or local workforce development programs

Draft Evaluation Form

- Suggestion to emphasize the need for a building emissions reduction component
- Suggestion to add new sections that clarify how projects will be evaluated during and after a project is selected to receive money from the Fund
- Requests for clarify regarding the indoor air quality criteria and the "other" criteria

Draft Application Outline

- Suggestions to request more information from applicants
 - An applicant's funding accomplishments
 - Update the question to allow an applicant to include accomplishments they think would be appropriate to add to their application
 - An applicant's financial size and stability (990 form)
 - Clarifying this will be asked in the google form application
 - Add a question explicitly asking plans to use labor from local, co-op, MBWE, disadvantaged business enterprises, and/or local workforce development programs
 - Adding a question of the applicant and any subcontractors if they qualify for any of these criteria

Draft Evaluation Form

- Suggestion to emphasize the need an building emissions reduction component
 - Update evaluation form to make it clear that building emissions reduction is required

Summary of Public Feedback on the Fund



Summary of Fund survey responses



- 60% of respondents were aware of the Fund, 40% were not.
- 80% of respondents were interested in applying, 20% were unsure.
- 60% of respondents were either service providers or building owners, 40% selected other:
 - One building owner and service provider
 - One building owner and affordable housing admin
 - One hospital administrator
 - One nonprofit worker
- A wide range of buildings.
 - Building uses included residential, commercial, medical, and education
- High interest for projects related to energy efficiency, renewable energy, fuel switching, and other technology solutions.
- A majority (66%) of respondents are interested in scoping, 44% in designing a project, 33% in funding a phase of a project, and 1 responded other.
- A majority of respondents (40%) are unsure how much money they are interested in, 30% are interested in \$1-3 million, 20% in \$50 500k, and 10% in \$500k 1 million.
- Respondents believe they can incorporate into a project proposal all of the listed environmental justice benefits.

Proposal for opening an initial grant program

Proposal for first application cycle:

The Review Board release up to \$750,000 for the first application cycle as a grant agreement.

Rationale:

- Initial cycle would allow the Review Board to begin to engage with nonprofits organizations that are undertaking decarbonization efforts as part of their regular programming and to better understand the existing landscape in Boston.
- Creates an opportunity to support and expand local initiatives that advance environmental justice.
- This would not prohibit simultaneously opening an RFP for planning and scoping services should the Review Board desire to do so.

Release a notice for the Equitable Emissions Investment Fund granting opportunity

- Open application on Friday, May 31, 2024
- Close application on Friday, July 12, 2024

Eligibility

- Applicants: Nonprofit organizations (registered 501c3 or organization with a fiscal sponsor).
- Projects must include:
 - Reductions in building emissions in Boston
 - Benefits to Environmental Justice Populations and populations disproportionately impacted by air pollution

 - Subject to change based on applications received and the board's discretion.



How Applications are Evaluated



Project Evaluation

Applications will be evaluated by the Review Board a public hearing

- Review Board will evaluate submitted applications <u>based on the following criteria</u>:
 - Emissions reductions (this component is required for all applications);
 - Benefits to affordable housing;
 - Benefits to tenants;
 - Benefits to labor and workforce development;
 - Benefits to outdoor air quality;
 - Benefits to indoor air quality and quality of life;
 - Climate resilience benefits;
 - Energy justice benefits;
 - And other benefits

The grantee will sign a grant agreement with any conditions stipulated by the Board

Staff propose:


• The Review Board release up to \$750,000 for the first grant application cycle of the Equitable Emissions Investment Fund as presented.

Notes:

- Actual funding awards to specific projects up to \$750,000 would be made during future public hearing(s).
- Board may choose to make multiple awards up to \$750,000 or choose to not expend the full \$750,000 following review of applications.













Existing Funding Sources

Energy Efficiency Conservation Block Grant

- Awarded a \$659,990 Energy Efficiency Conservation Block Grant (EECBG) from the Department of Energy to develop a Building Decarbonization Advisory Program.
- Will provide planning and scoping work for under resourced BERDO building owners.
- Anticipating being able to serve approximately 60 buildings with EECBG funds.
- 40% of funds must be spent in Justice 40 (environmental justice) neighborhoods.

American Rescue Plan Act (ARPA) Funds

- ARPA funds can be used for in-building projects in eligible properties.
- Approximately \$500,000 to **support energy efficiency and building emissions reductions** in eligible buildings.
- Proposing to use this funding to close gaps in "quick win" decarbonization projects identified through scoping.

Who would this program serve?



Program is designed for under-resourced BERDO building owners:

Residential buildings

- Self-managed with low condo fees and/or below market rents
- Low-income and affordable housing
- Older buildings
- Justice 40 and EJ census tracts

Commercial buildings

- Small Businesses
- Nonprofits and houses of worship
- Prioritize Justice 40 and EJ neighborhoods

Program Proposal



Contract with building science firm(s)

Must be Mass Save preferred vendor(s) to maximize Mass Save incentives

Eligible building owners will be able to receive:

- 1. Planning, scoping, and technical assistance, proposing to target \$10,000 per building and cap at \$15,000 per owner:
 - Customized "Zero Over Time" Plan and BERDO compliance strategy
 - Technical recommendations for energy efficiency and decarbonization projects
- 2. Additional ARPA funding may be applied to close gaps in small projects implemented in 2025 and 2026.

Program will be delivered through cohorts:

- Cohorts will run for approximately 3-4 months each. Number of buildings served will depend on vendors' capacity.
- Will allow for rolling applications.

Proposal for the Fund



The Fund could expand the number of buildings served by Decarbonization Advisory Program

- \$500,000 from the Fund could serve approximately 50 additional BERDO buildings.
- Scope of work would be the same for EECBG and EEIF funds.

If using money from the Fund:

- The vendor would be required to provide periodic updates to the Review Board.
- The Review Board may add criteria for selecting the building owners served with EEIF.

Proposed Timeline





Order of Events

- 1. Release Request for Proposals (RFP) following internal approvals and process.
- 2. Leave open for 4-6 weeks to allow for enough time for responses.
- 3. 1 week interview period.
- 4. Make award and contract.
 - Goal to have vendor(s) on board by September, 2024.
- 5. Run first cohort this coming fall.
 - Goal to have the first cohort receive completed plans by the end of the year.
 - Second cohort would start in early 2025.

We expect a multi-year contract.

Proposed Next Steps



Staff propose:


• The Review Board expends \$500,000 from the Equitable Emissions Investment Fund to expand the Building Decarbonization Advisory Program as presented.

Alternative option:

• Forego using The Fund in the proposed Decarbonization Advisory Program at this time with the option of releasing a separate Request for Proposals (RFP) in 2025 for scoping and planning tasks that leverages insights gained from this program's initial cohort.















Reminder and Update

Reporting deadline is May 15

This is for 2023 energy and water data

The Review Board approved delegating authority to approve up to two, three-month extensions to Environment Department starting May 1

- Only for this year (2024) and requested regular updates
- Only for building owners facing the following circumstances:
 - Despite receiving a timely request, one or more utility has been unable to provide necessary data.
 - A building owner has to verify their 2023 data and despite a timely request, the verifier will not be able to complete the verification by the May 15 deadline.
 - A building owner is waiting on information from the BERDO team that is necessary to complete reporting.
 - Other (please explain)





Reminder and Update

As of Monday, May 13, 2024:

- 146 requests for extensions have been made:
 - 14 Waiting for information from the BERDO team to complete reporting
 - 18 Engaged a third-party verifier but they are unable to complete the work before the deadline date
 - 54 One or more utility is unable to provide necessary data in time
 - 60 Other with an additional explanation
- 111 requests have been accepted
- 35 requests have been denied.



Description of Each Criteria

Criteria	Description	
Emissions reductions	The expected timeline and scale of direct Emissions reductions produced by the proposed project. Review Board members may consider metrics such as expected absolute Emissions reductions or expected Emissions reductions achieved per dollar spent.	
Benefits to affordable housing	The expected timeline and scale of direct benefits provided to low-income residents or residents of affordable housing, including, but not limited to, whether projects will support the development or protection of low-income or affordable housing.	
Benefits to tenants	The expected timeline and scale of direct benefits provided to low-income residents or residents of affordable housing, including, but not limited to, whether projects include anti-displacement measures, such as rent stabilization, rent assistance, and/or relocation assistance.
