



## **DESIGN UPDATES**

#### **BPS & BUSP Collaboration**

Embraced **holistic design** to include cross functional use of East and West Grandstands.

**1.** Reduced the width of the East & West Grandstands & size of the field to protect character-defining elements

2. Consolidated East & West program into wings.

3. Removed the bean building in The Grove & reduced pavement in The Grove

4. Replaced permanent fencing around The Grove with temporary fencing infrastructure

5. Moved scoreboard away from The Playstead

**6.** Aligned pathway system with FPAP recommendations

7. Removed vehicles from Playstead Road

**8** Introduced new 8 lane track and created new field sports opportunities

#### **KEY QUESTION**

• How do we best mitigate traffic congestion for NWSL soccer game days to serve both residents and visitors AND improve transportation challenges for existing large events at White Stadium?

#### **OUR APPROACH**

• The RFP asked for "a preliminary transportation plan". Boston Unity Soccer Partners (BUSP) included a multimodal plan in their submission. The City has since collaborated with Boston Unity Soccer to refine this plan using:

## **OUR APPROACH**

We then developed transportation goals for game days at White Stadium:



- Improve pedestrian safety, accessibility, and wayfinding at park entrances.
- **A**... Make it easy for neighborhood residents and park visitors to get around.
  - Encourage use of sustainable transportation choices.



- Ensure efficient traffic management during large events.
- **P** Use new and existing tools to protect parking and mobility in the surrounding neighborhoods, especially during big events.

## OTHER EVENTS AT WHITE STADIUM AND THE PLAYSTEAD

White Stadium has continued to be the home to many large events **without transportation plans**.

Game Day transportation plans will serve as a **blueprint for other large events**.



## 1. ENCOURAGE PUBLIC TRANSPORTATION

- Our first priority is encouraging people to take transit instead of driving
- Franklin Park is well served by public transit
- Boston Unity Soccer will run shuttles from Red Line and Orange Line stops
- We will partner with environmental organizations to implement sustainable transportation practices and raise awareness about green options







## **1. ENCOURAGE PUBLIC TRANSPORTATION**

Gillette Stadium Outer Parking Lots to Entrance - 16 minutes




## 2. SUPPORT PEDESTRIANS AND CYCLISTS



#### Improvements to support pedestrians and cyclists from Orange Line stations

- Important pedestrian routes like School St, Boylston St, and Glen Rd will be traffic calmed
- An improved bike connection is planned as part of the Egleston Square Redesign project
- Repaving of School St between Washington and Walnut planned for this year
- The City will bring the sidewalks on this walking route into good repair


## 2. SUPPORT PEDESTRIANS AND CYCLISTS



#### Safety Surge:

We're moving faster than ever before to make our City streets safer by using speed humps, signal changes, street design tools and other interventions needed to curb speeding, reduce crashes, and make neighborhoods more comfortable for walking, biking, and rolling.

Most streets around Franklin Park have had speed humps installed or are planned for 2024-2026.




## **3. PROVIDE SATELLITE PARKING**


- These lots are the only parking options for those who intend to drive and are intentionally far away from the stadium.
- Our strategy is to prevent game visitors from driving close to the stadium.
- There will be no parking for soccer fans on site, and no parking in nearby neighborhoods
- Boston Unity Soccer will provide satellite parking and shuttles to the stadium



# **3. PROVIDE SHUTTLES FROM PUBLIC TRANSIT AND SATELLITE PARKING**

- BUSP originally suggested reopening the Seaver St exit but decided against it due to community feedback
- Southern Shuttle Loops will serve:
  - Southwest satellite parking
  - East satellite Parking
  - Forest Hills MBTA stations
  - Red Line MBTA stations
- Shuttles on Circuit Drive will turn around in the Valley Gates lot








## 3. PROVIDE SHUTTLES FROM PUBLIC TRANSIT AND SATELLITE PARKING

Northern Shuttle Loops will serve:



## 3. PROVIDE SHUTTLES FROM PUBLIC TRANSIT AND SATELLITE PARKING








We've heard concerns from neighbors about the proposed shuttles running on a quarter mile of Walnut Ave. We've worked hard to explore all options to achieve our goals of minimizing impacts on residents around the park and encouraging public transit use.


#### Our updated proposal:

- Guarantee a reduction of shuttles from 57 to 40
- Restrict traffic on Walnut Ave to only residents, shuttles, and emergency vehicles. This will reduce traffic from 700 vehicles per hour to 150 vehicles per hour.
- Traffic details and infrastructure improvements will improve pedestrian safety.
- Parking restricted to residents and visitors with passes on game days
- BUSP is committed to exploring electric shuttles






#### Walnut Ave Weekday Hourly Traffic





- At peak times, traffic on Walnut Ave is
  ~700 vehicles per hour (12 vehicles per minute)
- Most of this traffic is from people passing through to avoid Egleston, not local residents.
- Our original proposal would add 28 vehicles per hour.

We were asked to look at using the bus stop on Columbus Ave.

- The platform is too small for two buses to drop off simultaneously
- The capacity of platform is 57 riders
- Concern about pedestrian safety walking from Columbus to the stadium
- Regular MBTA service at this stop would be negatively affected








We were asked to look at the impact of routing North Loop shuttles to Circuit Drive.

- Jackson Square <-> White Stadium via Walnut: Approx 6 to 7 minutes
- Jackson Square <-> White Stadium via Circuit Drive: **Approx 12 to 14 minutes**

Doubling the length of the trip will disincentivize T use and make driving seem more attractive. Our goal is to reduce driving and congestion as much as possible.



# **4. TRAFFIC OPERATIONS MANAGEMENT**



Traffic Operations Managers and Traffic Ambassadors will be provided for traffic flow and pedestrian safety

# **5. RIDESHARE AND CARPOOL**

We will use GPS and Variable Message Board to direct pick up and drop off to Humboldt/Seaver Street and station traffic management staff here.

- BTD will create a neighborhood-specific game day parking program for residents and their visitors on streets within the identified White Stadium walk area.
- The program will allow residents and their guests to park on the streets where parking is prohibited on game days.
  - 1 resident sticker per vehicle registered to an address in the Walk Area
  - 1 visitor parking placard per residential unit

## How would this work?



**Daniel** owns a building with three short-term rental units.

He receives **three visitor parking placards**, which his tenants can use.



**Maria** and **Julio** have two cars registered to their address.

Each car gets a **resident sticker** allowing them to park on the street. They also receive **one visitor parking placard** for their unit.



**Lucy** loves to host large barbecues. Parking is always tight in her neighborhood.

She applies for a **Block Party Permit** which allows her to shut down the street.

Keep in mind: Stickers and permits don't create new parking or guarantee parking will be available.






Key coordination and enforcement tools on game days

- Senior Operations Manager: Boston Unity Soccer will hire an executive leader to engage with community members for feedback and coordination on all operational concerns (traffic, parking, trash/cleanup, etc.)
- **Installation of Tow Zone Signs:** Add "Tow Zone No Stopping" signs on game days, exempting residents and their visitors with Jamaica Plain Resident Permit (RPP) stickers.
  - Effective 4 hours before and 1 hour after games
- **Dedicated BTD parking enforcement:** Assign a shift on game days. Towing would be activated to support enforcement
- New Event Fee Violation: Introduce a \$100 fine for parking violations on game days in designated areas.
  - \$100 matches the Fenway Event Parking violation fine.
  - \$100 fine + \$90+ tow = \$190+ plus a big hassle






- At the April transportation workshops, we shared a proposed Parking Restriction Area
- This is based on the radius we expect visitors would be willing to park and then walk.
- Based on the feedback we received, this is the updated proposal



- Based on community feedback, we have updated the proposed
  Parking Restriction
  Area to extend farther
  West.
- Prior Parking Restriction Area matched walking distance of Orange Line Stations
- Western extension reflects likely greater "park and walk" distance





# 7. PRESERVE MOBILITY FOR NON-SOCCER PARK VISITORS



Coordinating with Zoo, Golf, Playstead and Franklin Park permit holders

- Soccer game attendees will not be allowed to park in Franklin Park lots.
- We are committed to retaining parking for key park destinations such as the Zoo, Golf Course, and Shattuck picnic area and tennis courts.
- Park rangers and BPD officers will enforce parking restrictions with support from game day traffic ambassadors.
- All park visitors can access free Boston Unity Soccer shuttles from MBTA stations on game days.
- We will work closely with Franklin Park stakeholders such as the Zoo and Golf Course to craft an operational plan.

# 8. DAILY OPERATIONS

## **BPS Transportation Plan Status Update**

The BPS transportation plan is not under the IAG's purview, but we're sharing in the interest of being comprehensive.

## Data gathering:

- Attend athletic events at White Stadium to see how transportation functions
- Understand existing event frequency, size, and mode share

### Guiding principles and assumptions:

- Maintain existing park access points
- Maintain existing vehicle circulation roads
- Minimize impacts to the park's open or unpaved spaces
- Recognize that a road can be used for different purposes for different times or events
- Meet the need for BPS athletics and other BPS events
- Account for the plans of Boston Unity Soccer games and events permitted by the City

## Approach:

- Using the existing street layout and access points, explore opportunities to clearly define traffic, vehicle, and access spaces, and create efficiency for parking and circulation.
- Identify opportunities to create more flexibility in event management and circulation

## • Egleston Square Redesign

- Neighborhood traffic calming and accessibility improvements
- Bike connection between Southwest Corridor and Franklin Park via Atherton and School Street
- Neighborhood traffic calming and accessibility improvements
- Pedestrian and bike safety improvements on Walnut Ave between School Street and Seaver/Columbus



# **UPDATE: WALNUT AVE SHUTTLE ROUTE**

## Why Walnut Ave?

- In order to disincentivize driving and incentivize public transit use, it's critical to have attractive, fast, and easy ways to get from transit to the stadium.
- The more people who take transit, the fewer will drive, and the less congestion.
- To minimize congestion and impacts on residents, it's also important to distribute routes and drop off points around different sides of the park.
- The Columbus Ave bus stop is not viable due to the length of the platforms.
- Proposals to push shuttles to Seaver Street:
  - Reduce the incentive to take the shuttle, increasing walking through Parkside OR care traffic
  - Inequitably burden the Roxbury side of the park.
- **NOTE:** The plan will continue to evolve once games begin. We will engage in ongoing dialogue with neighbors through a governance structure to incorporate feedback.

# **5. RIDESHARE AND CARPOOL**

Currently, when there are large events at White Stadium, a great deal of drop off happens on Walnut/Sigourney, which is unsafe and causes congestion. There are multiple strategies we can pursue and scale up or down as needed:

#### First level:

- Variable message board at the intersection of Walnut and Seaver directing drop offs to the Seaver Street lot.
- Change the address for White Stadium in GIS mapping to Seaver Street so that drop offs are routed there
- Restrict parking and enforce no stopping on Walnut Ave from Montebello Road to Park Lane.
- Additional traffic ambassadors on Walnut to keep people moving along

**Second level:** All the above, plus variable message board saying Walnut is closed off to all traffic except shuttles, emergency vehicles, and residents

**Third level:** All the above, plus physically barricade oncoming traffic except for residents, except shuttles, emergency vehicles, and residents
