Residential Compliance Rate

- By Number of Buildings 41% 1259 of 3104 buildings (BERDO IDs)
- By Total Sqft **62%** 91,710,983 of 147,962,049 sqft

Commercial Compliance Rate

- By Number of Buildings 65% 1544 of 2373 buildings (BERDO IDs)
- By Total Sqft **75%** 172,977,398 of 230,284,413 sqft

Total Compliance Rate

- By Number of Buildings 49%
- By Total Sqft **70%** (87% of total sqft has been claimed)

Additional BERDO Reporting Updates



Update on Reporting Extensions

• 630 extension requests approved for August 15th reporting deadline

Follow-Up Emails

- Additional emails noting non-compliance will be sent to BERDO Account Holders
- 71% of buildings have been claimed. 87% of total sqft has been claimed

Letters on Non-Compliance

• Letters will be sent this week to all non-compliant building owners that have not yet requested an extension.

Additional Outreach Efforts

• Door-to-door outreach to buildings to determine contact information of property management that have not yet been claimed.



July 1, 2024*	Long-term Hardship Compliance Plan application deadline.	
August 15, 2024	Deadline for reporting with an approved extension request.	
September 1, 2024	Building Portfolio application deadline	
	Individual Compliance Schedule application deadline	
October 1 **	Short-term Hardship Compliance Plan application deadline.	
After July 1, 2024, long-term Hardship Compliance Plan applications are due April 1.
