## Boston Tree Alliance: Funding for Tree Planting and Care

## Notice of Funding Opportunity

The <u>Boston Tree Alliance</u>, the City of Boston, and Mass Audubon are pleased to announce that \$150,000 of grant funding is available for organizations to plant and care for trees on privately-owned land in the City of Boston in 2025.

#### **Summary Information**

<u>Application Due Dates:</u> Spring 2025 Planting: October 28th, 2024 Fall 2025 Planting: April 30th, 2025 Applicants may apply with an application for both spring and fall planting in the same year.

Total Amount Available: \$150,000

<u>Award Maximum:</u> \$25,000 per year per applicant organization

#### **Program Description**

The <u>Boston Tree Alliance Program</u> is a grant program for tree planting, care, and associated education. The program focuses on expanding access to trees and their benefits in under-canopied, environmental Justice communities in Boston. This program is funded by the American Rescue Plan Act (ARPA) through the City of Boston. Mass Audubon is contracted with the City to facilitate the distribution of grant funds and administer the program. The program provides funding support for nonprofit and community-based organizations to pursue tree planting, care, and associated educational activities in partnership with land owners on non-publicly owned lands.

The Boston Tree Alliance ("Alliance") is a coalition of nonprofit organizations, community-based organizations, urban forestry professionals, and stakeholders working collectively to equitably grow and care for new trees on private property in Boston. As the program's fiscal agent, Mass Audubon convenes Alliance meetings that inform the program's development. The Alliance works alongside the City of Boston to support and advance the goals of the <u>Urban Forest Plan</u> and the <u>Heat Plan</u>.

Organizations interested in tree planting and care are encouraged to apply for grant funding **regardless of previous experience**. Applications will be reviewed by Mass Audubon alongside the City of Boston. **Technical assistance is available for organizations to develop strong project proposals and implementation plans**.

Please note: 2024 was the first year of this grant program and there will be subsequent opportunities to apply for funding. If your organization would like assistance in building an

#### **Program Goals:**

The <u>Urban Forest Plan</u> (UFP), which guides the efforts of the program, found that 60% of Boston's existing tree canopy is located on private land, and that the overall tree canopy is not equitably distributed across neighborhoods. Boston Tree Alliance Tree Planting and Care grant projects collectively aim to:

- Equitably increase access to trees and their benefits with a focus on low-canopy areas, urban heat islands, and environmental justice communities in the City of Boston.
- Fund care and maintenance for trees to increase survival rates and promote long-term growth of the urban canopy.
- Invest in long-term resilience including urban heat island mitigation and improvements to public health outcomes.
- Build awareness and competency of tree planting and care best practices through public engagement and education.
- Advance climate resilience and urban forestry strategies identified in the Heat Plan and UFP.

### **Eligible Applicants**

Community-based organizations and non-profit organizations that work with or serve Boston residents and Boston-based organizations are eligible to apply for funding through this grant program. Organizations may partner on joint applications. The project narrative section of the application should include a description of the nature of any partnership involved.

For-profit corporations, public agencies, and individuals not representing a community-based or non-profit organization are not eligible to apply for funding through

this grant program. These stakeholders are encouraged to identify and collaborate with a local non-profit or community-based organization.

Boston residents and property owners may request a tree planting on their property using <u>this form</u>. Every effort will be made to fulfill new tree requests by matching requests with project proposals as appropriate.

<u>Required documents:</u> Applicant organizations shall provide:

- A Taxpayer Identification Number (TIN)
- Organizations performing tree planting and maintenance activities shall provide proof of commercial general liability insurance issued in the applicant organization's name with the amount of not less than \$1,000,000 each occurrence and \$2,000,000 in the aggregate and workers compensation insurance in statutory amounts.
- Following project approval, funding recipients will be required to sign a Contractor Agreement with Mass Audubon.

### **Eligible Projects and Expenses**

The Boston Tree Alliance grant program provides funds for tree planting and care with a focus on projects located in under-canopied, environmental justice neighborhoods that experience the worst impacts of urban heat islands, outlined in the <u>Urban Forest Plan</u> <u>Neighborhood Strategies</u>.

Organizations may apply for a maximum of \$25,000 per grant year (this may be for multiple planting seasons).

#### Eligible Lands

Eligible applicants may apply for funding for a project to be conducted on private land within the city of Boston. Lands owned by federal, state, or municipal government are not eligible for this funding opportunity.

#### Eligible Uses of Funding

Examples of eligible activities may include:

- Planting single trees on one or more properties
- Planting multiple trees on one or more properties
- Planting trees in microforests or groves (groups of trees)
- Site preparation for tree planting projects (depaving, decompaction, etc. as directly related to tree planting)
- **Required**: 2-year maintenance activities associated with tree planting projects (watering, weeding, inspection, pruning, mulching, staking)

**Ineligible Projects and Expenses** 

- Tree planting and maintenance on publicly-owned land
- Tree care costs for trees **not** planted with Boston Tree Alliance funds
- Projects that do not meet the program goals of the Boston Tree Alliance

Applicants will be required to provide the following information prior to project implementation:

- Proposed location(s) for tree planting.
  - o Provide the address(es) of expected tree planting location
  - o Indicate that you would like assistance in finding tree planting locations from the Alliance or that planting locations are still in process
- Project narrative that includes:
  - o Project goal and expected impact (e.g., relationship to Alliance goals of addressing tree equity, urban heat, and historic disinvestment)
  - o Organizational capacity and level of urban forestry/arboriculture knowledge o If jointly applying, the nature of the partnership between organizations
- Landowner agreement(s) and a tree planting and 2-year maintenance plan must be submitted and approved before funds can be expended (Details found in the application form)

Applicants should provide an anticipated budget as a cost estimate that **may** include these eligible expenses:

- Planning: staff or subcontracted time to identify sites, secure landowner agreements, and plan implementation (labor only, no material costs expected)
- Planting: costs of trees, mulch, staking, gator bags, items for time-of-planting (materials), and staff or subcontracted planting time (labor)
- Maintenance: 2 years from time-of-planting costs of watering, resetting mulch (materials), and staff or subcontracted inspection time (labor)
- Engagement: 2 years from time-of-planting costs of landowner education for tree planting and care of grant-funded trees

## **Application Submittal**

Applications can be submitted through the <u>online application form</u>. All applicant materials can be found on the grant application portal at boston.gov/tree-grants.

## **Application Support**

#### **Financial Information and Reporting Requirements**

Applicants selected to receive funding will be required to attend an orientation session to review project requirements before implementation. No match is required to receive funding.

Once all requested materials are received, grantees will be required to submit a project invoice to Mass Audubon. Funds will be distributed to grantees approximately 2 weeks after invoices are received, prior to project implementation.
