COMMITTEE HEARING NOTICE

November 27, 2024

The Boston City Council's Committee on Ways and Means will hold a hearing on **Tuesday, December 3, 2024 at 10:00 am** in the **Iannella Chamber, 5th Floor, Boston City Hall**. This hearing was previously on Dockets #0479 and #0999; it will now be on Dockets #0999, #1211, and #1715.

The subjects of the hearing are:

Docket #0999, Order for a hearing to discuss ways to diversify the City of Boston's revenue.
Docket #1211, Order for a hearing for the Boston City Council to address next steps after the Failed Property Tax Reclassification Home Rule Petition Through Audit.
Docket #1715, Order relative to the adoption of Tax Classification in the City of Boston in FY 2025.

These matters were sponsored by Councilors Brian Worrell, John FitzGerald, Tania Fernandes Anderson, Julia Mejia, and Erin Murphy and were referred to the Committee on June 12, 2024 (#0999), August 7, 2024 (#1211), and November 20, 2024 (#1715).
