# **SESSION BEGINS - 2:00 PM**

#### I. WELCOME

- a. Genesis Pimentel welcomed attendees.
- b. New EEOS Chief Brian Swett and incoming Director of Historic Preservation, Kathy Kottaridis, introduced themselves to the Commission.

# III. MA250 EVENT + GRANT DEBRIEF

a. Commissioners discussed the MA250 event and the grant. Some organizations on the Commission were able to get grants while some were not.



#### IV. POLICY MEMO REVIEW AND UPDATE

- a. Genesis Pimentel reviewed the Policy Memo and its legal implications for the Commissioners to put to a vote. It was rewritten to better reflect the goals of the change.
- b. The Commissioners voted 26 Yes, 0 No.

# V. CITY RECOMMENDATIONS FOR 250 DISCUSSION

- a. Alex Meadow introduced himself as the new Deputy Director for Partnerships and gave a presentation of the City of Boston's vision for the 250th after internal multidepartmental conversations and consultation with the Mayor. The impact areas that the presentation suggested focusing on include vehicles for funding, events, markers, exhibits, archival projects, and communications.
  - i. Commissioner Noelle Trent expressed concern around competing against the City for funding resources. Alex Meadow explained that this was not the City's intention and that the City means to support organizations.
  - ii. Commissioner Giordana Mecagni discussed needing a process for auditing the trails and markers created.
  - iii. Commissioner Chelsea Blanchard expressed wanting a landmark/plaque program to exist inside of the Office of Historic Preservation long-term.
  - iv. Commissioner Lydia Lowe suggested creating a database and sharing resources for trails and other community initiatives.
  - v. Chair Jean-Luc Pierite discussed making sure initiatives consider local tribes and are culturally sensitive, perhaps through mapping or a toolkit.
