In accordance with the Procedures and Criteria for the Issuance of Parking Freeze Permits adopted under M.G.L. Chapter 111, Section 31C, and pursuant to the Building Emissions Reduction and Disclosure Ordinance, Boston City Code, Ordinances, Section 7-2.2, the City of Boston Air Pollution Control Commission will hold a **virtual public hearing at 2:30 p.m. on January 15, 2025**, to review the following projects to regulate and control air pollution so as to promote the public health and welfare of Boston residents.

Any matter posted as part of a public hearing may be deliberated on at a subsequent meeting.

Members of the public may share public comments during the hearing. The Air Pollution Control Commission will also accept written testimony for agenda items via email at apcc@boston.gov prior to the hearing. Written testimony should be submitted by January 15, 2025 at noon.

PUBLIC HEARING:

Application for a Modified Downtown Boston Parking Freeze Permit from The RMR Group LLC on behalf of SIR Boston Realty Trust for 8 exempt spaces in a garage at 124 N Washington Street. This application requests a new permit for existing parking spaces which are not currently associated with a permit. Issuance of permit would have no effect on the Downtown Boston parking freeze bank.

Application for a New South Boston Parking Freeze Permit from WS Development on behalf of Seaport L Title Holder LLC for 173 commercial spaces in a garage at 33 Boston Wharf Rd. The existing facility consists of 86 commercial parking spaces under an existing permit. This permit request is associated with a project to demolish the existing surface parking lot in order to redevelop the site and build an underground parking garage. Issuance of the permit would withdraw 87 spaces from the South Boston parking freeze bank.

Application for a Modified South Boston Parking Freeze Permit from WS Development on behalf



of Seaport L Title Holder LLC for 115 commercial spaces in a garage at 25 Pier 4 Blvd. The existing facility consists of 78 commercial parking spaces. This permit modification is to demolish the existing surface parking lot in order to redevelop the site and build an underground parking garage. Issuance of the permit would withdraw 37 spaces from the South Boston parking freeze bank.
