COMMITTEE HEARING NOTICE

January 7, 2025

The Boston City Council's Committee on Labor, Workforce and Economic Development will hold a hearing on **Tuesday, January 14, 2025 at 10:00 am**. This hearing will be held **virtually**.

The subject of the hearing is:

Docket #0116, Message and order authorizing the City of Boston to accept and expend the amount of Eight Hundred Sixty Thousand One Hundred Sixty-Nine Dollars and Seventy Cents (\$860,169.70) in the form of a grant for the One Stop Career Center grant, awarded by MassHire Department of Career Services to be administered by the Office of Workforce Development. The grant will fund comprehensive career services and resources to unemployed job seekers such as reviewing job postings, career counseling and job coaching, education/skills training, and job placement assistance.

This matter was sponsored by Mayor Michelle Wu and was referred to the Committee on January 8, 2025.

NOTICE: The Boston City Council may have a quorum participating due to standing committees of the City Council consisting of both voting and non-voting members. However, members participating in this duly posted meeting are participating and deliberating only in conjunction with the business of the standing committee.
