SIGNATURE REQUIREMENTS

3000 Certified Signatures of Registered Voters required for Mayor

1500 Certified Signatures of Registered Voters required for At Large City Councillor

200 Certified Signatures of Registered Voters required for District City Councillor

Residency Requirement for <u>District City Councillor</u>: Candidates running for District City Councillor must have been an inhabitant of said district at least one year preceding the election (St. 1982, Chapter 605, Section 6). For Election Day November 4, 2025, candidates must have resided in their district prior to November 5, 2024.

The Boston Election Department will certify only up to an additional 20% more than the requirement.

DEADLINE DATES

April 16 th	9:00 a.m First hour and day for making application for nomination papers at the Boston Election Department in Boston City Hall Room 241. In order for candidates to receive nomination papers, a statement of Candidacy must be completed by the candidate (not a representative), in the Election Commission office.
April 30 th	9:00 a.m First hour and day for distribution of nomination papers from the Boston Election Department in Boston City Hall Room 241.
May 13 th	5:00 p.m Last hour and day for making application for nomination papers at the Boston Election Department in Boston City Hall Room 241.
May 20 th	5:00 p.m Last hour and day for filing nomination papers at the Boston Election Department in Boston City Hall Room 241.
June 24th	5:00 p.m Last hour and day for registrars to complete certification of signatures.
July 1st	5:00 p.m Last hour and day for filing withdrawals or objections to nomination of candidates for City Offices at the Boston Election Department in Boston City Hall Room 241.
July 1st	5:00 p.m Last hour and day for filing withdrawals of nomination of candidates for City Offices where substitutions can be made at the Boston Election Department in Boston City Hall Room 241.
July 2 nd	5:00 p.m Last hour and day for filing substitutions caused by withdrawals or ineligibility at the Boston Election Department in Boston City Hall Room 241.

Early Voting Schedule for Preliminary Municipal Election – August 30, 31, September 2nd through 5th

August 30th 5:00 p.m. -- Last hour and day for registration of voters for Preliminary Municipal Election.

September 9th 7:00 a.m. to 8:00 p.m. -- <u>PRELIMINARY MUNICIPAL ELECTION</u>.

Early Voting Schedule for Municipal Election – October 25th through October 31st

October 25th 5:00 p.m. -- Last hour and day for registration of voters for Municipal Election.

November 4th 7:00 a.m. to 8:00 p.m. -- MUNICIPAL ELECTION.
